# Boland **Jones**

Board Chair

In the mid 1980's, Boland Jones started his first company — American Network Exchange (AMNEX) — which provided the first alternatives to the AT&T® operator service. Mr. Jones foresaw a future in business communications applications and founded PGi (Premiere Global Services) in 1991. Mr. Jones was identified in 1998 as Entrepreneur of the Year of the Southwest Region by Ernst & Young and in 2008 named Georgia's #5 Top Performing CEO in 2008 by the Atlanta Business Journal. In 2015 PGi was acquired by Siris Capital Group for \$1 billion. Mr. Jones received his BS from Miami University in Oxford, Ohio.



#### Jeff Arnold

Jeff Arnold is chairman and CEO of Sharecare, the digital health company helping people manage all their health in one place, which he founded in 2010 with Dr. Mehmet Oz, in partnership with Harpo Productions, Sony Pictures Television and Discovery Communications. Previously, Arnold was Chairman and CEO of HowStuffWorks.com, an award-winning online resource used by millions of people each month, which he sold to Discovery Communications, where he served as Chief Digital Strategy Officer, and Chief Architect of The Curiosity Project until December 2011. In 1998, he founded and served as CEO of WebMD, the first healthcare company to harness the power of the Internet to create a destination for consumers, healthcare institutions and physicians to find trustworthy medical information. Less than a year after Arnold founded WebMD, it was acquired by Healtheon for \$7.9 billion.



## Rodney Bullard

Rodney Bullard is currently Vice President of Community Affairs at Chick-fil-A, Inc. and Executive Director of the Chick-fil-A Foundation where he leads the company's corporate community and philanthropic strategy, which is focused on fostering youth and furthering education.

Before coming to Chick-fil-A, Rodney served as an Assistant United States Attorney prosecuting complex criminal cases. For his service, the United States Attorney General presented him with the Department of Justice Director's Award. Prior to this role, Rodney was selected as a White House Fellow, the nation's most prestigious public service Fellowship. As a White House Fellow, Rodney was placed at NASA working directly for the NASA Administrator. A decorated veteran, Rodney also served in the United States Air Force Judge Advocate General Corps eventually working at the Pentagon as a Congressional Legislative Liaison in the Office of the Secretary of the Air Force.

Dr. Sanjay Gupta is the multiple Emmy<sup>®</sup> award winning chief medical correspondent for CNN. Gupta, a practicing neurosurgeon, plays an integral role in CNN's reporting on health and medical news for all of CNN's shows domestically and internationally, and contributes to CNN.com. His medical training and public health policy experience distinguishes his reporting from war zones and natural disasters, as well as on a range of medical and scientific topics.

In addition to his work for CNN, Gupta is a member of the staff and faculty at the Emory University School of Medicine. He is associate chief of neurosurgery at Grady Memorial Hospital and regularly performs surgery at Emory University and Grady hospitals. In 2009 the company was acquired by Waste Management. In 2010, Advertising Age named Bagster one of the 'Hottest Brands in America'. QuarterMoore and its partners are the largest Portable On Demand Storage (PODS) franchise group in the world operating in a number of markets across North America. In 2015, the Ontario Teacher's Pension Plan acquired PODS Enterprises, Inc. for \$1 billion.

Lane serves on the boards of several private companies and non-profit organizations and is a member of Young Presidents Organization (YPO). Lane received his undergraduate degree in Economics from Hampden-Sydney College.
